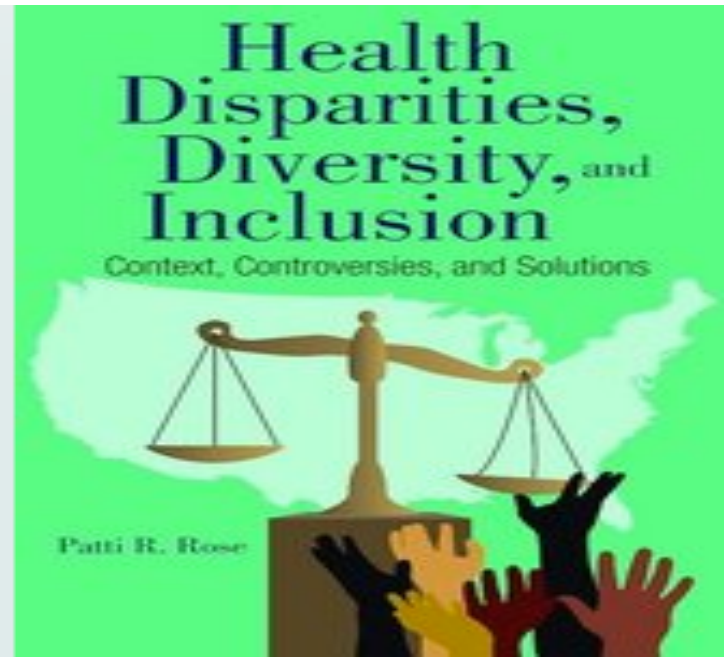

Dr. Patti Rose acquired an MPH from Yale University, and her Ed.D from Teachers College, Columbia University. Academically, she has served at various levels (Adjunct Professor, Instructor, and Associate Professor) at several institutions in the U.S. (University of Miami, Florida International University, Springfield College, Worcester State College, Nova Southeastern University and Barry University) and internationally, as a Visiting Professor, in Shanghai, China (Jiatong University) and Guangzhou, China (Jinan University), for the JNU Summer School Program and will do so at Feng Chia University, in Taiwan, soon. She is a Yale University candidate Alumni interviewer, President of Yale University's South Florida Black Alumni Association and serves as a National Project Advisory Committee (NPAC) Member for the Office of Minority Health, US DHHS. Her administrative roles include serving as President and CEO of Plainfield Health Center in Plainfield, New Jersey and as Vice President of Behavioral Health Services at The Jessie Trice Center for Community Health in Miami, Florida. She developed a DVD entitled "Cultural Competency: A Public Health Imperative" for Yale University's School of Public Health, and received their Public Health Service Award for a career that "exemplifies the primacy of the social mission of public health." Dr. Rose has given keynote addresses and presentations/ workshops, for many venues in the U.S. including, LSU, Yale University, Teachers College, Columbia University, LeMoyne College, Ross University, Des Moines University Medical School, Miami Dade College, the American Public Health Association and the National Association of Health Care Executives and internationally in Nairobi Kenya, Barcelona, Spain, Paris, France, Aruba and St. Thomas. Her books include *Cultural Competency for Health Administration and Public Health*, published by Jones and Bartlett Learning and *Cultural Competency for the Health Professions*, published by the same publisher. Her newest book is *Health Disparities, Diversity and Inclusion: Controversies, Contexts and Solutions*. Currently, she serves as President of Rose Consulting, Administrator and writer for her Blog, Natural Is Cool Enough (N.I.C.E.), and she is a Huffington Post Contributor and writes about various topics including the series "50 Countries And Counting: A Naturalista's Travel Adventures, documenting her world excursions with travel tips. Born in Queens, NY, Dr. Rose has lived with her husband and two children in South Florida for 22 years.

Her areas of expertise are educational leadership and pedagogy, curriculum development, course design, educational research, educational technology, program evaluation, measurement and testing, student academic support, faculty development, educational policy development and implementation, and strategic planning.
